In recent years, Steve has been the President of the Minnesota chapters of both the American College of Trial Lawyers and the American Board of Trial Advocates. Steve is a fellow of the International Society of Barristers and also has an AV® Peer Review Rating in the *MartindaleHubbell* legal directory. He has been selected for inclusion in *Minnesota Super Lawyers* 2003-2025 Editions, and has been named to the *Top 100 Minnesota Super Lawyers* over the past several years. Steve's dedication to the legal profession has earned him two gubernatorial appointments to the Governor's Judicial Selection Panel. Outside of his practice, Steve is a longtime supporter of Southern Minnesota Regional Legal Services (SMRLS), an organization that provides free, high-quality legal help to low-income people in critical civil matters. Steve has served as the Chair of the SMRLS Campaign for Legal Aid for over 25 years, raising over \$15 million, and he is an active pro bono volunteer.
